Farmland Preservation Update

Todd Vigland, Land Protection Specialist with the Grand Traverse Regional Land Conservancy, provided an update on recent grant activity. The USDA's Natural Resources Conservation Service, Regional Conservation Partnership Program (RCPP) was approved for 8 million in water quality projects and will be administered by several partners. A grant application to Great Lakes Initiative was denied, but applications are still pending with the Resource Conservation Program and Clean Michigan Initiative. Matt McDonough, Director of Land Protection with Grand Traverse Regional Land Conservancy is working with the USDA on their contract requirements to bring them more in line with the smaller scale farms in this area. Work continues with Acme Township landowners on the 2011 scoring.

OLD BUSINESS

Sych requested setting the annual meeting date to the second Wednesday in April. Staff will notify Board members prior to that date next year.

PUBLIC COMMENT

Largent reported the Household Hazardous Waste (HHW) collections are being held more often. The next HHW drop-off is scheduled for April 21st from 1:00 p.m. to 7:00 p.m.
