

**NOTICE OF VOTER REGISTRATION
PRESIDENTIAL PRIMARY ELECTION
MARCH 10, 2020**

The last day to register to vote in any manner other than in-person with the local clerk is **February 24, 2020**

In-person registration with the local clerk with proof of residency period is **February 25, 2020 through 8:00 p.m. on March 10, 2020**. Election Day registrants may apply and vote an absent voter ballot in person when registering at the clerk’s office.

The city and township clerks of Grand Traverse County will be at their offices during their regular business hours and additional special hours the weekend before the election, for the purpose of taking applications for registration from qualified persons. No one may vote in the March 10, 2020 Presidential Primary Election unless they are on the registration roll of the city or township clerk by 8:00 p.m. election day. VOTER IDENTIFICATION REQUIREMENT IN EFFECT

Every Michigan voter who offers to vote in the polls must comply with the requirement by showing picture identification or signing an affidavit attesting that he or she is not in possession of picture identification. (See MCL 168.523 for picture identification requirement)
